## PROGRAMME GOALS

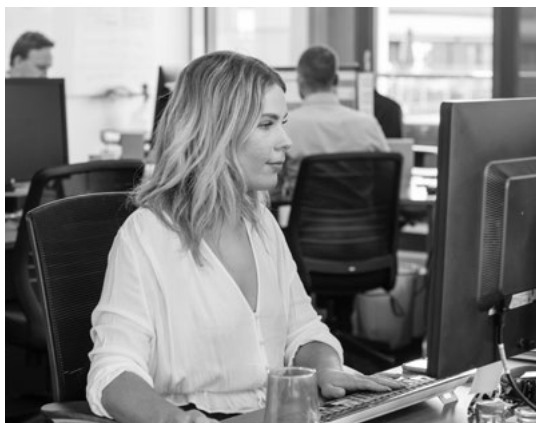

You will have the opportunity to hear career stories from experienced CFOs and insights from business leaders at four Leader Forums.

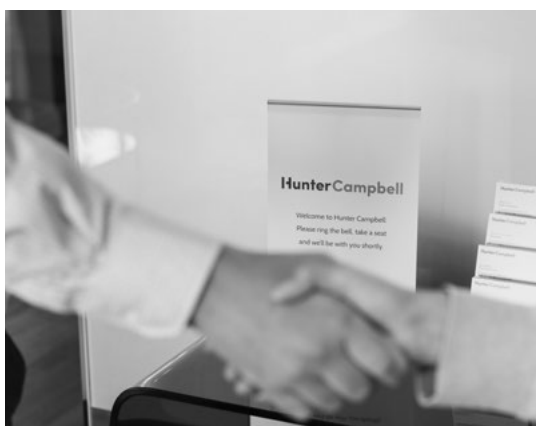
